Dated Lahore, the 29th June, 2010

No.SOR-III(S&GAD)1-2/2002(P) In exercise of the powers conferred on him under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), the Governor of the Punjab is pleased to direct that in the Punjab Agriculture Department (On Farm Water Management) Recruitment Rules, 2003 the following amendments shall be made:

AMENDMENTS

In the said rules, in the Schedule:

- (1) against Sr. No. 11(System Analyst) for the entries in columns No. 5 & 7, the following shall be substituted:

Column No. 5

- "a) MCS/MIT/MSC (Computer Science) (Second Division) from a recognized University; or
b) BCS/BS (Computer Science)/BS (Information Technology) (four Years) (Second Division) from a recognized University; and
c) Five years experience in each case in system analysis, design, implementation and programming such as Database, Oracle having experience and working on different operating systems environment."

Column No. 7

- "a) By promotion on the basis of seniority-cum-fitness from amongst the Computer Programmers having five years service as Computer Programmer (BS-17); or
b) If none is available for promotion then by initial recruitment."

- (2) against Sr. No. 21 (Computer Programmer), for the existing entries in Columns No. 5, 7, 8 & 9, the following shall be substituted:

Column No. 5

- "a) Four years Bachelor's Degree in Computer Science (Second Division) from a recognized University after sixteen years of education; and
b) Five years experience in project/system analysis, design, implementation and programming such as Database, Oracle."

Column No. 7


- "a) By initial recruitment; or
b) By transfer from other Government departments."

Column No. 8 & 9


